Assuming such ten votes per share of Class B Common Stock, Mr. Christian's beneficial ownership of Class A Common Stock and Class B Common Stock together represent approximately 65.1% of the combined voting power of the Issuer's outstanding Class A Common Stock and Class B Common Stock.
